Open Issues

- Membership report (Sheila Bolduc-Simpson):
 - Membership growth has been greatest during periods of bad times.
 - 470 total in-unit faculty. We need to recruit more union members. We are at 45%. We need 25 more members before the end of the year.
 - Sheila would like to have the drawing for membership recruitment.
 - A decision to award 3 amounts for recruitment efforts by members was approved in the amounts of 2 \$100 checks and 1 \$500 check to be made payable to the winning recruiters.
 - Winning recruiters will be recognized at the UFF Winter Break Party on December 5th.
- Treasurer report (Michelle Angeletti):
 - UFF sent \$6000+ in February and \$6000+ in August.
 - Account is currently at \$30,000+
 - Michelle will double check IRS filing status for back taxes. Our chapter is supposed to file under the state UFF, but there was an error in processing the tax returns.
 - Morgan T. Paine asked if UFF covers our chapter under Errors of Omission Insurance.
 Concerned was raised over liability for the officers.
 - Beth asked how much was put in the Budget for incentives. Michelle will need to look this
 up
 - Michelle will look into getting a Bank Card from the Bank to allow for easier access of funds for special events. This will also help with transparency of the account.
 - Beth requested a \$1000 budget for the Bar Louie Event. This amount was approved.
 Michelle will either put the cost of the event on the Chapter's new Bank Card or will use her own credit card and seek reimbursement.
- Grievance report (David Steckler)
