Chapter budget review and approval: Motion to approve the UFF-FGCU budget by Nora, second by Carolynne. The UFF FGCU budget was approved unanimously. Elizabeth will bring the forms for the Presidents to sign at our next meeting so they can be sent to Sasha at UFF State

#### **II.** Bargaining (Scott):

- The UFF Team appreciates the members that are attending the bargaining meetings, and feel that it is making a difference in how managements behaves.
- b. Our most recent counter-proposal was 2.8% ACB.
- c. Thus far, management says they are willing to sign an MOU with UFF-FGCU to open up more than the requisite 2 articles during next year so we can continue with the efforts currently underway.
- d. They are still considering all other items we are trying to bargain.
- e. Tony Barringer continues to assure us he'll report on what Administration's response is for our counter proposals, complete with justifications. He explained that it has been difficult to get the Provost and President to discuss together, since they have both been doing so much traveling. He assured Scott this morning that he'd give an answer soon.
  - f. Bargaining meetings will resume next week twice weekly.

- h. Compression and Inversion study: There was a conference call with McKnight. They are amenable to providing just the raw data and will provide a quote for doing just the C&I portion soon. Discussion will continuing at Bargaining

#### III. Grievance (Carolynne):

- a. **SRHM** arbitrability hearing occurred Monday Oct 28<sup>th</sup>. Each party has 2 weeks to provide any additional items, (Nov 12). We expect to hear whether the arbitrator finds in favor of going to arbitration. If so, we may need to get a different arbitrator. "Arbitration is arbitrary"
  - i. Carolynne encourages us all to read Graham Picklesimer's <u>Pre-Hearing Brief Submitted on Behalf of United Faculty of Florida</u> Graham's grasp of the the English language is quite good. See especially p 11 'quibbling about incantations' and p 13 where he addressed the University complaint that the "effort" involved in reviewing the cited articles is "fundamentally unfair."
  - ii. Carolynne continues to field calls and meet with the faculty, some of who said they feel 'abandoned' by the Union. She suggested, and the EC agreed, to have a lunch meeting with the SRHM faculty. (note: Carolynne was told that two new job descriptions were just posted, that look quite similar to the people whose contracts were violated.) However, at 11:30 (Nora did not see them at the FGCU Faculty Jobs page)
  - iii. Jaffar volunteered to initiate drafting a resolution to put before the FGCU Senate asking them also for a show of solidarity in expecting the CBA be followed.
  - iv. We may also prepare a press-release.
